- Our Cadettes enjoyed an overnight camping experience and Night Owl program at Camp Sacajawea on November 1<sup>st</sup> and November 2<sup>nd</sup>. It was so much fun! There was a night hike, owl calling, smores, stargazing, lots of information about owls and other nocturnal animals, and of course camping.
- We appreciate our partnership with Kappa Delta at U of L so we could host the Girl Scout Tea/Cupcake Fun on Sunday, November 10<sup>th</sup> at First Christian Church. - All troops must be registered to participate. Cookie parent must be registered with the troop, have a current background check on file, and have completed Girl Scout 105 online training.
- All 2018 to 2019 End of the Year reports should have been submitted and approved.

- Double check that all girls are showing up on the troop's member profile so that their orders will be processed.
- Cookie parents for your troop must set aside time during one of the December meetings to discuss with parents specifics of cookie sales (with older girl troops, the girls should be included in this), reminding parents that their daughter's troop is self-supporting and product sales often determine a troop's operating budget for the year. Each family has a responsibility to participate in product sales to support not only your daughter and her troop but also to support the Skyline Council. A generous amount of cookie sale products is used to support and maintain our 3 local camps. Parents who choose to make cash donations to the troop versus actually selling cookies are not showing the needed support to the Skyline Council.
- Parents must sign permission forms for their daughter to participate.
   This includes the identification asked for on the form (SSN, driver's license number, etc.). This signed permission form will stay on file with the troop's product sales manager and be used as needed by GSVSC for collection issues.
- Girls start selling cookies on January 1<sup>st</sup>. Unsold products cannot be returned to the troop or GSVSC. The money is owed to the troop from your cookie order. If your customer decides that they no longer want their preordered products, then the girl/parent who took the initial order will need to sell them.
- Money from cookie sales is due to the troop's product sales manager. Parents should not deposit money into the troop's account or into their personal account in order to write a check to the troop. All money (cash, checks) must be given directly to the troop's product sales manager (or cookie mom). If money is not turned in on time by the parent, GSVSC policy is that an incident report is completed and turned in to Council headquarters.
- Do not bundle deposits list deposits by girls' individual sales. If only one bank deposit is made, label the deposit slip will all of the girls' names. Do not list unsold products as expenses.
- The product sales manager will determine a deadline for when money must be submitted to her so that she can meet Detria's GSVSC deadline. Scheduling this date when you have a regular troop meeting works well.
- Cookie booth lottery for Lynchburg Campbell County is done via Google Doc designed by Sarah and will start on January 9<sup>th</sup>. Usual locations are Sam's, Kroger, Walmart, Moore's Country Store, and JoAnn's. You

- may, however, choose your own cookie booth location you must let Sarah know the date, time, and location.
- Please consider letting your girls participate in cookie booth sales. Part of our job as leaders is to help teach our girls the importance of good work ethic.
- Is the cookie sale a service project, an entrepreneurial skills program, or a money-earning project for the troop?
  - It is both an entrepreneurial skills program and a moneyearning project because your goal is to make money for the troop and you cannot do that if you do not have the proper skills.
  - It is a major income for the troop.
  - It is a service project for the council. 80-85% of their operating budget comes from cookie sales.
  - It is also a service project for donations to the military and a large percentage of the proceeds that troops earn are directed back to local communities through their own service projects.
  - Girls develop important social skills to speak to customers, sell product, handle money, and marketing skills.
  - The success of individual sales are based on the girls' ability to step up and take action and to think outside the box at how to be successful.
  - A lot of time is spent talking to the girls about the logistics of cookie booth sales, how much cookies cost, what are profits, how much change to give, how much money the troop earns per box of cookies sold, where does the rest of the cookie money go, how do they decide how to spend the money, when will they know how many cookies will be sold, the best way to answer a customer's questions, and how to promote their product. The main focus is on how to sell and interact with people.
